NOTICE TO MEMBERS: TRANSITION ELECTION SCENARIO A AND 2026 ELECTION CALENDAR.

Dear Members of the Kenya Veterinary Association,

In accordance with the Transition Clauses of the 2025 Constitution and the approved Transitional Electoral Provisions for April 2026 Elections, the National Executive Council of the Kenya Veterinary Association hereby notifies the membership of the applicable Election Scenario and the 2026 election calendar.

Following a review of the constitutional timelines and the transitional provisions, **Scenario A (Interim Period of 90–119 days)** has been adopted as the applicable framework to guide the conduct of the Association's elections.

Under **Scenario A**:

- An Interim Electoral Committee will be appointed within the timelines prescribed from the Commencement Date of **16 January 2026**; and
- The election process will be conducted in strict compliance with **Article 22 of the KVA Constitution** and **the Transitional Electoral Provisions for April 2026 Elections**, including member notification, nominations, publication of candidates, campaigning, and voting at the Annual General Meeting.

A detailed **Transition and Election Calendar**, aligned with the Constitution and the Transition Regulations, has been approved and is attached to this notice for members' information and guidance.

Members are encouraged to review the calendar carefully and to participate actively in the electoral process in accordance with the Constitution and the established procedures.

Further communication will be issued by the Interim Electoral Committee once constituted, including guidance on nominations and electoral conduct.
